

Survey details



- Half-yearly survey of IR professionals (DIRK members)
- Internet-based written survey from 01.03.2016 to 18.03.2016
- Basis: 293 DIRK members (2-2015: 310)
- Responses : 59=20% (2-2015: 24%)
- Broken down by indices, the responses came from:
 - 7 DAX companies (= 23% of all DAX-listed companies)
 - 10 MDAX companies (= 20% of all MDAX-listed companies)
 - 9 TecDAX companies (= 30% of all TecDAX-listed companies)
 - 8 SDAX companies (= 16% of all SDAX-listed companies)
 - 24 companies that are not part of a selection index
- 100% of all the companies to have responded belong to the Prime Standard segment

- Half-yearly survey of IR professionals (CIRA members)
- Internet-based written survey from 01.03.2016 to 18.03.2016
- Basis: 67 CIRA members
- Responses : 10=15% (2-2015: 26%)



IR club

- Half-yearly survey of IR professionals (IR Club members)
- Internet-based written survey from 01.03.2016 to 18.03.2016
- Basis: 59 SIRV members
- Responses : 6=10% (2-2015: 47%)





By country – left-hand bar: assessment of current situation; right-hand bar: assessment of future situation




Assessment of current situation of companies in Germany from year to year




Assessment of current situation of companies in Switzerland from year to year






Assessment of current situation of companies in Austria from year to year















Economic assessment shows increase for the future




Assessment of current prospect




The future indicator stands at 25 points in Germany. This is a solid increase versus the second half of 2015.


Current number of IR employees (full-time)


Current number of IR employees in Germany (full-time) - Indices






Current sell-side analyst coverage in Germany












Current sell-side analyst coverage in Germany - Industries



Development of number of sell-side analysts








